The latest estimates of take-up rates shows that take-up for all children aged under 16 at the end of March 2023 was 83 per cent. They also continuously promote the payment through social media, news releases and the distribution of materials to libraries, nurseries and schools.






Equalities Committee

SCOTTISH GOVERNMENT UPDATES

Tackling Hate Crime - The Hate Crime and Public Order (Scotland) Act will provide greater protection for victims and communities from 1 April.

Boosting Scotland's Renewables - Views are being sought on proposals for the sustainable use of bioenergy, including growing crops which can be converted into electricity, heat and fuels.

Support for adult survivors of childhood abuse - Up to £2.23 million funding is being made available to third sector organisations providing counselling, peer support and practical support to adult survivors of childhood abuse.

Fair Work milestone - The number of Scottish employers registered as paying the real Living Wage has hit a new high of 3,500.

Defence in an Independent Scotland - An independent Scotland would strive for peace and prosperity and without the UK's dangerous nuclear weapons.

Child Poverty - 100,000 children are being lifted out of poverty because of policies by the SNP Scottish Government. Policies like the game-changing Scottish Child Payment are enhancing children's lives.

Junior Doctors - Applications for medical training posts in Scotland are at record levels with more junior doctors joining the NHS than ever before.
