IN THE SCOTTISH PARLIAMENT

First Minister's Questions

During FMQ's recently, I asked the FM what assessment the Scottish Government has made of warnings from not-for-profit social care providers regarding the impact of increased employers National Insurance Contributions, and the impact this could have on the sector in Scotland. Anas Sarwar's Westminster colleagues must fully reimburse the Scottish Government for these plans.



Stage 3 Debate: Social Security (Amendment) (S) Bill

Social Security Bill

I was glad to speak in this debate recently, and witness the passing of the Social Security (Amendment) (Scotland) Bill. This Bill will enhance the rights of Social Security Scotland claimants, through for example, protecting benefits from inflation. This will also protect the Winter Heating Payment, ensuring every pensioner from 2025 receives some form of payment.

Rural Question

I recently asked the Scottish Government what it is doing to promote the Scottish food industry. In a joint statement, the Scottish Pelagic Processors Association and the Scottish Seafood Association have recently stated the Labour UK Government's increase to National Insurance contributions could threaten the seafood industry in Scotland. I asked the Minister what discussions they have had with the UK Government on this impact.







SCOTTISH GOVERNMENT UPDATES

N THE 2025/26 BUDGET

Winter Heating Payment reinstated - The Scottish Government will provide financial support to all pensioners next year, after Labour axed the Winter Fuel Payment.

Record NHS funding - Record £2 billion increase in frontline NHS spending taking overall health and social care investment to £21 billion to reduce NHS waiting lists, making it easier for people to see their GP.

Scrapping the Two-Child Cap - The Scottish Government will mitigate the UK Government's cruel two-child limit from 2026, lifting 15,000 children out of poverty.

Investment in Town Centres - £62 million will be invested in town centres and regeneration projects.

Affordable Housing - £768 million will be put into affordable housing to deliver at least 8,000 homes.

Uplift for Culture Sector - The Scottish Government will deliver £34 million increase for the culture budget next year and reiterates commitment to £100 million investment.

Retail Crime - £3 million will be delivered to Police Scotland to specifically tackle shoplifting and retail crime.

Local Government - A record £15 billion for local government to support the services communities rely on.
