Winter Fuel Payment

Last week saw Scotland's coldest early winter night since 1998, with temperatures reaching as low as -11.2°C. I recently asked the Cabinet Secretary for Health whether he shares my concern and the concern of stakeholders like Age Scotland, that the health of older people across the country will be jeopardised as a result of the UK Labour Government's cruel decision to cut the Winter Fuel Payment.

It was then incredibly welcome that the Scottish Government announced universal Winter Fuel Payments will be re-introduced. This will see every Scottish pensioner receive some form of payment from next year, with those most in need receiving the highest payment. This is further proof that while the Labour Party push pensioners into poverty, the SNP will protect them.



Members' Business — World COPD Day

World COPD Day

I was pleased to lead a World COPD Day debate recently. I sadly lost my mother to this terrible disease in 2012 so I was grateful to have the opportunity to raise awareness and highlight the importance of early detection. Clydebank has an unfortunate asbestos legacy - a substance that can increase your risk of COPD - so it is my duty to raise awareness of the condition.

Keeping Our Roads Safe

The Scottish Government is seeking views on whether to reduce the national speed limit for cars on single carriageways from 60 to 50mph. I have been undertaking a Road Safety survey in East Dunbartonshire, so it is great to see our Scottish Government committed to ensuring safer roads. This would be a vital step to reducing road casualties.





SCOTTISH GOVERNMENT UPDATES

<u>Football helping to tackle poverty</u> - An initiative to provide free after school and holiday clubs for families on low incomes has helped more than 3,500 children to <u>attend football and other sport sessions</u>.

More young people helped to spot signs of abuse - More than 27,000 young people have benefited from education and awareness-raising sessions on tackling gender-based violence over six months, thanks to 45 grassroots organisations across Scotland.

Joint working to support communities - A report has shown how partnership working between the Scottish Government and councils is helping to deliver on community priorities.

<u>Scotland's Green Jobs</u> - Scotland's green job market has tripled since 2021. According to PwC, Scotland is leading the UK in the creation of green jobs.

Strengthening tenants' rights - New legislation will introduce a range of measures to improve renting in Scotland, including strengthening tenants' rights to keep a pet.

Improving eating disorder services - People affected by an eating disorder can expect higher and more consistent standards of care following the roll-out of new national guidance for services.

<u>Scotland's Migration Service expanded</u> - Scotland's Migration Service, which provides information and advice for people, employers and investors, has been expanded.
